Trial Period and Conditions of Contract

There is a two-week trial period (10 business days) starting the first day of care during which the provider or parent may discontinue care and terminate the contract without any notice given and the deposit will be refunded. After the trial period, a two-week notice must be given by the parent when leaving Little Learners or the deposit will be forfeited. When a two-week notice is given, the refundable deposit will be credited to the last week of tuition. Deposits are only refundable with a two-week notice after attendance begins or if notice of discontinuing enrollment is given two weeks prior to a planned start date. The provider reserves the right to terminate services if the terms of the Parent Handbook are not followed, immunizations are not kept current, or if the child's behavior is consistently unmanageable or harmful.
